All vehicles are sold under the terms and conditions outlined in the Auction Rules and NAAA Arbitration Policy. Buyers and sellers are responsible for reviewing all announcements, sale lights, and vehicle disclosures before completing any transaction. Arbitration will not be considered for issues that do not meet policy thresholds, including non-visible or non-dripping fluid leaks. The Auction is not a party to the sale and assumes no responsibility for vehicle condition or representation. Final decisions on arbitration are made at the sole discretion of Auction Management.



# **AUCTION RULES and POLICIES**

Revised Date July 15,2025

- 1. This Auction is a "<u>DEALER ONLY AUCTION</u>." The general public is not invited. You, the Dealer will be held fully responsible for the actions of your guests, this includes all drivers, mechanics etc. Children under the age of 12 years will not be allowed in the Auction Lanes. All children should be accompanied by an adult over the age of 18 and becomes the sole responsibility of the dealer who is in attendance with the child. All guests (including children) must be signed into the facility at the Auction Office and must wear a badge that declares them as a guest of the attending dealer responsible. Your help in this area will be appreciated.
- 2. All dealers must be registered and approved before conducting business. The Auction reserves the right to refuse service to anyone.
- 3. All vehicles sold outside of Auction Ring, are sold "**AS IS**" no ride and drive or arbitration is allowed. Both Buyer and Seller must inform the office of such a sale and sign the necessary paperwork to complete the transaction.
- 4. Central Arkansas Auto Auction abides by NAAA Polices with CAAA Addendum. See Attached.
- 5. The Seller has 30 days to produce a title to the auction for the buyer. Seller is required to produce a title that meets the guidelines and requirements of the State of Arkansas. Late titles must be announced. Under the "Late Title" announcement, the seller has 45 days; ALL FRANCHISE DEALERS fall under the "Late Title" guideline of 45 days. Failure to produce a title under these guidelines can result in the buyer having the option to return the vehicle to the Auction, to be picked up by the seller. The buyer MUST give the Auction 24 hours notice of intent to return a vehicle for late title. Vehicles with over 500 miles from when sold are not eligible for return.
- 6. A fee will be charged for drafts returned to the Auction for any reason other than valid paperwork errors by the Seller. The maximum allowed by law, (minimum of \$25) will be added to the price of the draft. If the draft is resubmitted a handling charge of \$25 will be added. If the draft is picked up at the Auction facility all fees will be collected at that time, including draft fee and return fee.
- 7. Any check returned to the auction for non-payment will be subject to return fees, \$100 for first rerun, then an additional \$100 for NSF Return on the second try. All return checks must be paid in cash or cashier checks, no replacement checks will be accepted.
- 8. All vehicles on Auction property are considered by our insurance as the Dealer's responsibility. The Auction does not insure and is not liable for theft, accidents, and fire or by acts of God (i.e. flood, hail, tornado, or lightning).
- 9. All vehicles must have a Gate Pass in order to leave the Auction property. Gate Passes are issued in the Auction Office by Auction Personnel. The office, with regard to time limits and other conditions may issue test Drive passes.

### **ARBITRATION POLICY**

Central Arkansas Auto Auction adheres to National Auto Auction Association Arbitration policies and standards with CAAA Addendum. See Attached

## **ODOMETER POLICY**

The Auction does not guarantee odometer reading, mileage statements, bill of sales, etc. The Auction does not guarantee miles indicated on any vehicle offered at the auction. Sellers must announce if odometer is broken or in excess of mechanical limits. The Auction will not become involved in mileage disputes. Any irregularity in the odometer must be brought to the attention of the Auction on the day of sale. Sellers are required to take back any vehicle with a documented odometer rollback problem. All vehicles offered at the Auction are subject to inspection by county, state, local and federal law enforcement officers.

### **PAYMENT POLICY**

All payments are **due on the day of sale** and must be remitted prior to the vehicle's removal from the premises.

Accepted Payment Methods: We accept the following forms of payment: Cash, Cashier's Check, Company Check, or Approved Finance Company Check. Personal checks are not accepted. In accordance with Auction Insurance policies and regardless of title presence, each vehicle must be paid for with a separate check.

<u>Late Payment Fee:</u> A **late payment fee of \$75** will be assessed per vehicle. This fee applies starting at **12:00 PM (noon) on Thursday** and will reoccur **at 12:00 pm (noon) Monday** until the outstanding balance is settled.

<u>Automated Clearing House (ACH) Payments:</u> Customers may enroll in automated ACH payments by completing and signing the **ACH Authorization Contract**. Funds will be debited in accordance with the terms outlined in the executed contract.

<u>Delinquent Vehicle Payment Resolution:</u> Vehicles without an accepted form of payment by **12:00 PM (noon) on Thursday** (the day after the sale) will be subject to **flooring** or debited via **ACH** or any other available payment method at the auction's discretion.

#### **VENUE**
